## 1. BACKGROUND

The State of Libya, as a Party to the United Nations Convention to Combat Desertification (UNCCD), is committed to regularly reporting on the progress achieved in combating land degradation, enhancing resilience to drought, and advancing Sustainable Development Goal (SDG) 15.3 on Land Degradation Neutrality (LDN). UNCCD reporting constitutes a strategic obligation for Libya, enabling the country to demonstrate progress, mobilize technical and financial support, influence global policy processes, and strengthen evidence-based decision-making at national and sub-national levels.

In 2017, the UNCCD Conference of the Parties, through Decision 7/COP.13, adopted the UNCCD 2018–2030 Strategic Framework and strongly encouraged Parties to apply and align their national policies, programs, and plans on desertification, land degradation and drought (DLDD) with the Framework. As part of this commitment, the Global Environment Facility (GEF), as the financial mechanism of the Convention, is supporting 39 country Parties through the Umbrella 2 Project to strengthen national reporting.

The objective of the Umbrella 2 Project is to support national focal points, national executing entities, and relevant stakeholders in a participatory and inter-institutional process to prepare and submit their national reports to the UNCCD by 2026. Through this project, Libyan institutions and the national focal point will receive technical and institutional support to improve data collection (default data, spatial mapping, drought indicators, LDN progress and recovery indicators, knowledge and technology inventories, and financial flows), conduct comprehensive reviews, and undertake detailed assessments of progress made in implementing the UNCCD Strategic Framework and SDG 15.3. The generated information will be used to draft and validate Libya's 2026 National Report to the UNCCD and strengthen national communication, advocacy, and planning related to LDN targets.

Libya faces specific challenges in monitoring land degradation due to limited data accessibility, institutional fragmentation, the impacts of prolonged instability, and constrained technical capacities. In recent years, however, the country has demonstrated renewed commitment to strengthening environmental governance, enhancing drought monitoring systems, and improving coordination among national institutions. The Umbrella Programme, supported by UNEP and the OSS, aims to reinforce national capacities to produce an accurate, complete, and validated 2026 National Report that meets UNCCD standards.

The national reporting is based on (i) indicators to measure the progress against the UNCCD's strategic framework, and (ii) an implementation framework to assess actions at national and sub-national levels relevant for UNCCD implementation.

This consultancy will therefore support Libya's national reporting process by providing advanced technical analysis, strengthening institutional mechanisms, streamlining data collection and reporting workflows, and enhancing communication and engagement with key national stakeholders.

## 2. OBJECTIVE OF THE ASSIGNMENT

The overall objective of this consultancy is to provide technical, analytical, and institutional support to the Libya national team to ensure the production of a high-quality, comprehensive, and validated National Report for the 2026 UNCCD reporting cycle. More specifically, the consultancy aims to:

- Strengthen national technical capacities for collecting, processing and analysing data related to land degradation, drought resilience and LDN indicators;
- Reinforce institutional coordination, ensuring effective collaboration among all national stakeholders involved in the UNCCD reporting process with the active involvement of the national steering committee in coordination mechanisms and review meetings;
- Assess and enhance the participation of women, youth and all segments of society in LDN efforts, ensuring their systematic integration across the UNCCD reporting cycle;
- Enhance long-term national monitoring and reporting systems, including data management, knowledge management and methodological tools;
- Support the drafting, review and consolidation of all sections of the 2026 National Report, in full alignment with UNCCD methodological and reporting requirements;
- Facilitate national validation and stakeholder engagement, ensuring strong ownership, transparency and sustainability of the reporting process.

## 3. SCOPE OF WORK AND TASKS

The consultancy will be implemented in five sequential steps, each aligned with the specific objectives of the assignment. These steps reflect the logical progression required to strengthen national capacities, consolidate data, integrate cross-cutting issues, and prepare the 2026 National Report.

### **Step 1: Data inventory and consolidation to strengthen technical capacities for data collection and structuring**

- 1.1. Conduct a comprehensive inventory of all biophysical, socioeconomic and institutional datasets relevant to UNCCD/LDN reporting, including:
  - land cover, land productivity, soil and biomass carbon;
  - drought-related indicators;
  - gender-disaggregated data;
  - land-use planning documents, policies and regulatory frameworks.
- 1.2. Prepare a Data Inventory Report detailing:
  - existing data sources and custodians;
  - dataset descriptions and associated metadata;
  - quality assessment and completeness;
  - identified data gaps and recommendations for improvement.
- 1.3. Compile all relevant raw datasets and establish a structured national dataset repository compliant with UNCCD and OSS requirements.

## **Step 2: Data processing, analysis and database preparation to improve long-term national monitoring systems**

- 2.1. Process and analyze datasets using relevant UNCCD methodologies and tools (e.g., Trends.Earth, Earth Observation data, national statistics) ;
- 2.2. Organize and prepare raw and processed datasets in formats suitable for upload to PRAIS 4 ;
- 2.3. Support the national team in updating and validating the LDN monitoring database, ensuring data quality, coherence and readiness for reporting.

## **Step 3: Integration of woman and youth to ensure effective inclusion of cross-cutting issues**

- 3.1. Conduct a gender analysis relevant to LDN, land-use sectors and Identify existing gender-responsive policies, institutional frameworks and key gaps;
- 3.2. Prepare a Gender Integration Report with practical recommendations for the reporting process;
- 3.2. Develop a youth and local population engagement plan specifying:
  - Consultations to be conducted;
  - Engagement approaches and communication channels;
  - responsibilities of institutions and actors;
  - policy entry-points for inclusive participation.

## **Step 4: Capacity building, communication and awareness to reinforce institutional coordination and support sustained national engagement**

- 4.1. Design and implement a national communication and awareness strategy to strengthen engagement on LDN and reporting obligations.
  - key messages adapted to national priorities;
  - stakeholder mapping and engagement pathways;
  - awareness and outreach tools (media, digital content, briefs, flyers, posters).
- 4.3. Support OSS and the national focal point in delivering capacity-building and training sessions, particularly on:
  - reporting methodologies;
  - data management and analysis;
  - use of PRAIS 4, Trends. Earth and other relevant platforms.

## **Step 5: Support drafting, consolidation and validation of the 2026 national report**

- 5.1. Prepare draft versions of all sections of the 2026 National Report in alignment with the PRAIS 4 structure.
- 5.2. Ensure effective integration of the participation of women and youth and other cross-cutting dimensions.
- 5.3. Facilitate consultations and validation meetings of the National Steering Committee, including the presentation of findings and analytical outputs.
- 5.4. Incorporate all comments and prepare the final validated version of the Libya 2026 National Report, ready for formal submission to the UNCCD.

## 4. DURATION AND EXPECTED DELIVERABLES

The consultancy will be implemented with a total estimated level of effort of 62 working days, distributed over a four-month period starting from the date of contract signature. The Consultant will be responsible for organizing the work plan to ensure the timely delivery of all outputs in line with the agreed deliverables schedule.

The Consultant is expected to remain available throughout the assignment for regular coordination and technical exchanges with the OSS team and the relevant national institutions in Libya (UNCCD FP, National Steering Committee). A degree of flexibility may be required to accommodate stakeholder availability, data access constraints, and the scheduling of national consultations or validation meetings. ## 5. REQUIRED QUALIFICATIONS AND EXPERIENCE

The Consultant must meet the following minimum qualifications and experience requirements to successfully carry out the assignment:

### 5.1 Educational Background

An advanced university degree (Master's level or higher) in environmental sciences, natural resource management, geography, GIS/remote sensing, climate change, social sciences, or any other field relevant to land degradation monitoring.

### 5.2 Professional Experience

A minimum of seven (7) years of progressively responsible professional experience in one or more of the following areas:

- land degradation monitoring and assessment;
- environmental and sustainable land management;
- climate change adaptation and ecosystem management;
- data analysis and geospatial information systems.

### 5.3 Technical Competencies

The Consultant must demonstrate proven competence in the following areas:

- Remote sensing and geospatial analysis, including the use of Landsat, Sentinel and other Earth Observation datasets.
- Statistical and spatial data processing, analysis and visualization.
- Institutional capacity-building, stakeholder engagement and facilitation of inter-agency coordination.
- Gender and social inclusion analysis, with the ability to integrate cross-cutting dimensions into environmental monitoring and reporting processes.

### 5.4 Communication and Language Skills

- Excellent writing, synthesis and reporting skills in English, with the ability to produce high-quality analytical and technical documents.
- Strong interpersonal and communication skills, enabling effective engagement with national and international stakeholders.

### 5.5 Contextual Knowledge and Additional Assets

- Knowledge of the Libya institutional, policy and environmental governance context is a significant asset.
- Ability to work independently while ensuring regular coordination with the national team and project partners.
- Demonstrated ability to deliver outputs within tight deadlines and manage multiple tasks in a results-oriented environment.

Candidates are invited to submit applications which should include a technical and a financial offer.

✓ **Technical offer:**

The technical offer must include the following elements:

- Supporting documents proving experience;

The financial offer must be presented in USD including taxes.

## 7. EVALUATION METHOD AND CRITERIA

The offers of the consultants will be evaluated based on the combined scoring method:

- Technical qualifications (100 points max.) weight: 70%
- Financial offer (100 points max.) weight: 30%

A two-stage procedure will be used in evaluating the offers, with evaluation of the technical qualifications being completed prior to any financial bid being compared. Only the financial bids of applicants who passed the minimum technical qualifications score of 70 points will be evaluated.
